Appendectomy

Appendectomy is the surgical removal of the appendix. This is usually done when the appendix becomes infected.

Laparoscopic vs. Open Surgery

A Laparoscopic appendectomy is the removal of the appendix by placing a laparoscope through the umbilical port and additional trocars in the abdominal cavity. The appendix is identified, dissected from surrounding structures and its blood supply divided. The appendix is transected with staples or suture and removed. (ICD-9 Codes: 47.01, 47.11)

An appendectomy by traditional surgical method is an incision two to three inches in length is made through the skin and the layers of the abdominal wall in the area of the appendix. The surgeon enters the abdomen and looks for the appendix, usually located in the right lower abdomen. After examining the area around the appendix to be certain that no additional problem is present, the appendix is removed. This is done by freeing the appendix from its attachment to the abdomen and to the colon, cutting the appendix from the colon, and sewing the over the hole in the colon. If an abscess is present, the pus can be drained with drains (rubber tubes) that go from the abscess and out through the skin. The abdominal incision then is closed. (ICD-9 Codes: 47.09, 47.19)

Methodology

Measures used to compare these hospitals are: the number of patients treated at each hospital, the percentage of patients who died (mortality), the percentage of patients who developed problems (complications), the average number of days people stay in each hospital (length-of-stay), and each hospital's average charges (costs). This report relies on Virginia All Patient Data (2004). The complications used are identified using guidelines from the Agency for Healthcare Research and Quality (AHRQ).

Legend

Patients Per Year: Number of patients treated at each hospital; **n/a:** when hospital volume was zero (0), n/a was applied to rate of mortality, complication, length of stay and cost.

Mortality: % of patients who died while being treated

Total Charges: Average hospital charges for treatment; excludes physician fees and outpatient services.

LOS: Average number of days people stay in the hospital for treatment.

Complications: % of patients who developed problems while being treated

Hmh: Hemorrhage Complications

Pneu: Pneumonia

Misc: Miscellaneous complications

Iat: Iatrogenic or Care Related Complications

Res: Respiratory Problems

UXE: Unexplained Events

UTI: Urinary Tract Infection
